THE IP SECTION GOES "ON THE ROAD AGAIN" WITH ITS WEST TEXAS PROBONO TOUR IN SPRING 2022

The Intellectual Property Law Section of the State Bar of Texas (IP Section) is planning its Pro Bono Tour to the "Big Sky" country of West Texas scheduled for Spring 2022.

The Pro Bono Tour will have two stops. The first workshop will be held on Thursday, March 31, 2022 at The University of Texas Permian Basin in Odessa, Texas. The second workshop will be held on Friday, April 1, 2022 at Sul Ross University in Alpine, Texas. The location of these two universities will allow the IP Section, the United States Patent and Trademark Office (USPTO), and Texas Accountants and Lawyers for the Arts (TALA) to serve the greater West Texas region, including Alpine, Marfa, Fort Stockton, Marathon, Terlingua, Fort Davis, Pecos, El Paso, San Angelo, Midland, and Odessa.

So, dust off your hat and boots and join us for the Pro Bono Tour.

Over the past four years, volunteer attorneys from the IP Section, in collaboration with the USPTO, and under the leadership of Regional Director Hope Shimabuku, have conducted the Pro Bono Tour. The Pro Bono Tour is a state-wide program to provide educational workshops on how to protect the intellectual capital of small business owners, entrepreneurs, and inventors located in underserved communities throughout Texas. This year we plan to add TALA as an additional cosponsor. TALA's participation will allow for the expansion of the tour's digital out-reach and event coordination as well as provide additional volunteer attorneys specializing in copyright law.

The IP Section and the USPTO have held seven Pro Bono Tour workshops—from the Texas Gulf Coast to the Rio Grande Valley and from far West Texas to East Texas—at local colleges and universities. Over the years, the IP Section has offered this free program to 400+ stakeholders in Corpus Christi, McAllen, Fort Worth, El Paso, Waco, Nacogdoches, and Lubbock. The workshops have been extremely well-received.

These full-day workshops are broken into three sessions. The first session is an educational session designed to provide an overview and introduction to intellectual property law, including patents, trademarks, copyrights, and trade secrets, and is typically led by intellectual property lawyers who specialize in that specific area of the law. USPTO personnel also introduce stakeholders to the patent and trademark application process, including a step-by-step demonstration of how to file a patent or trademark application and how to search freely-available internet resources so that the stakeholders can have a better idea about whether their invention is patentable or if their brand is available for trademark use.

The second session is a break-out session with three concurrent tracks—software, mechanical/electrical inventions, copyrights, and consumer products. The purpose of this break-out session is to enable participants to work with attorneys and USPTO personnel specializing in their technical or business area, and also allow stakeholders with similar backgrounds to ask questions and share common experiences.

The final session consists of 20-minute one-on-one consultations between lawyers and the participants. During these confidential sessions, the volunteer attorney provides free individualized legal assistance to the inventor, entrepreneur or artists on a particular problem or issue.

Over the last three years, this program, led by Fort Worth practitioner Joe Cleveland, has been very fortunate to have assembled a great team of 10-12 volunteer attorneys with a wide variety of different backgrounds, experiences and practice areas allowing the IP Section and the USPTO to serve the needs of these underserved and underrepresented communities across Texas. Joe Cleveland commented that "Without exception, every lawyer who has participated in the program has greatly enjoyed the opportunity to give back to our community in such a unique and significant way."
